DESCRIPTION

CERA NATURALE (Natural Wax) is a special water-based dirt protective, for all glossy lime-based mineral finishing:

- glossy plaster in all its range;
- Venetian plaster in all its range.

CERA NATURALE is composed by genuine bees wax, pure *savon de Marseille* and additives in an homogeneous blend. It's completely solvent free (0% VOC).

CERA NATURALE increases the glossiness and confers to the surface washable properties, maintaining an outstanding breathethrough capacity.

CERA NATURALE is suitable for **indoor** wall surfaces protection only.

APPLICATION

Ready to use, mix carefully before using.

Let the surface to dry out for at least **48 hours**.

Apply the wax with a soft (non-abrasive) sponge for 1m² (about 11ft²) at a time, until the surface has completely absorbed it.

After about 30/40 minutes, polish the surface using a non-woven fabric cloth (micro fibre or *TNT*/tissue-non-tissue cloth).

STORAGE

The product maintains its properties for a period of 12 months if protected from excessive heat and cold.

The storage temperature must be included between **+5°C** and **+30°C**. **Protect from frost.**

SAFETY GUIDELINES

Avoid contact with skin and eyes. If contact occurs, rinse thoroughly with water. For more information consult the safety sheet.

DISPOSAL

The product must be disposed in agreement with current regulations.

Empty containers have to be sent to recycling plants.
